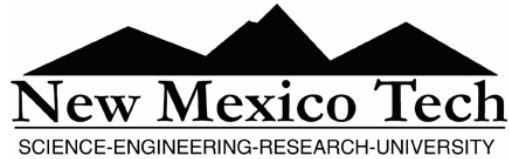

REQUIREMENTS FOR TESTING

Degreed Engineers in a mining discipline must have at least 2 years of experience.

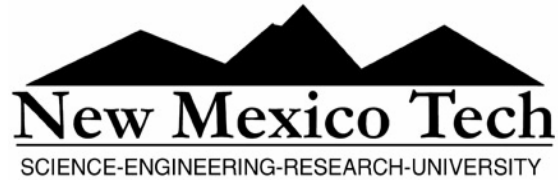
Underground personnel with only 4 years of UG mining must be certified as Mine Examiners AND perform the duties of a Mine Examiner for at least 6 months prior to applying for and taking the Mine Foreman's Examination.

4 years of UG Coal Mine Experience
Current in First Aid Training and Annual Refresher training
Certification by MSHA in Methane Detection/Oxygen deficiency
Valid driver's license
Additional information as required in the packet

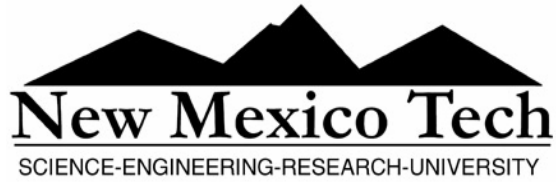

Instructions for filling out Application
For Examination as an Underground Coal Mine Foreman

- A. Items 1-6 are self explanatory.
- B. Item #7. New Mexico state law requires at least 4 years of experience in or about underground coal mines. Credit will be given to degreed engineers in mining disciplines that have at least 2 years of experience in or about underground coal mines.
- C. Item #8. Please attach a photocopy of any certificate held in the state of New Mexico.
- D. Item #9. Please attach a photocopy of any certificate held in any state other than New Mexico. (Applicants who are certified as Underground Mine Foreman in another state will be granted temporary certification upon receipt and review of completed application packet. Temporary certification will remain in effect until the next available examination date, but shall not exceed 90 calendar days.
- E. Item #10. Please attach a photocopy of the MSHA qualification card, or the certification/qualification roster signed by the MSHA qualifying official. If no card or qualification from MSHA has been issued but the applicant is Flame Safety Lamp qualified, applicant will be required to demonstrate the use of the gas detection device utilized at the current mine operation at the time of the examination.
- F. Item #11. Self explanatory.
- G. Item #12. (These letters should attest to the moral character of the applicant, how long the person has known the applicant, knowledge of the applicants work experience etc. They should be individually authored and not a standard format signed by 4 different personnel.)

Please insure that you understand that if this box is checked the examination results will be sent to only the applicant and will not be given to the applicants employer either orally or in written form.
