- 1. Call to Order. Regent Peacock called the meeting to order at 9:01 a.m.
- 2. Approval of Agenda. Chair Peacock
- 3. Information Items, Chair Peacock
 - a) **Financial Review through June 30, 2021,** VP McDaniel presented a summary of the Employee Benefit Trust finances. He said the net position has increased by \$700,000 when compared to June 30, 2020. The Trust has more than \$5 million, with more than \$1.538 million in cash.
 - b) NMPSIA Report for Non-health Insurance and Dissolution Report. VP McDaniel presented a detailed report on the potentials of moving NMT employee non-health insurance (life, death, dismemberment, etc.) to the New Mexico Public Schools Insurance Authority (NMPSIA) and the possible dissolution of the Employee Benefit Trust. He further summarized the plan offered by NMPSIA and how it would benefit employees and the university. Regent Armijo moved to recommend to the NMT

Board of Regents that the Employee Benefit Trust transfer all insurance to NMPSIA. Regent King seconded. The motion passed unanimously. It was also determined that the possible dissolution of the Employee Benefit Trust will be revisited at a later date.
